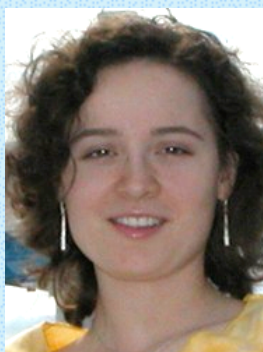

Results of Research Outputs Analysis

- 62% of the scores given by both groups coincide
- The remaining scores differ for the following reasons:
 - data gap
 - different interpretation of commitments and data
 - need to compare Russia's performance with the performance of other countries
- Further research should be conducted
